The TRI Team provides transparent, authentic professional development training aimed at preventing drug/alcohol abuse, suicide, and sexual assault. We share reality based scenarios that deal with PTSD and Post Traumatic Growth. To interact with participants, we use technology, multi-media, reality-based scenarios, and live-polling.

SAPR, ASAP, and/or DSPO training is purpose driven for TRI Team, because we have personally experienced managing a rapist/stalker, substance abuse issues, or suicidal contemplation. Authentically, we walk the talk.

Since 2017, more than 20,000 military leaders, active military members, family service representatives, SARC and/or VA have attended TRI's performance-based trainings. Audience size has ranged from seven to 1,500.
